Chapter 4
Necessity of a Fourth Branch

MY FELLOW AMERICANS: *The factual allegations in this chapter will be proven in our courts during our lawsuits against the traitors. Sources are not provided for that reason. From this point on, I tell what I know, express my opinions, and call the criminals in our government what they are. I mean no disrespect to the vast majority – our GOOD government employees.*

THE OVERTHROW of our other three branches of government necessitates a fourth branch.

MY FELLOW AMERICANS: These words may shock many of you, but know from the start that the United States has already been taken over. How? Incrementally, secretly, treacherously.

A coup against the United States has been taking place since the founding of our Country. Our Founding Fathers, and many of our *good* leaders since, have forewarned us of the dangers of centralized banking, militarism, federalism, communism, fascism, socialism, globalism, and the like. But, instead of sounding the alarm, our *corrupt* leaders aided in the incremental overthrow of our government and our *corrupt* Press increasingly kept us in the dark or lied to us to cover it all up.

A small minority of the Earth's inhabitants, mostly rich bankers in the beginning, decided a few centuries ago to form a "*New World Order*" to takeover countries and their resources, including ours, and consolidate them into a "*one world government*" under their control.

In the final battle of the Napoleonic Wars (1803-1815), members of the already very wealthy Rothschild family, who, because of their financial connections in the war, received inside information well in advance of other officials and the public, defrauded the British government and the people of Great Britain into believing that Napoleon had won the war, and then, as prices plummeted, bought up a large portion of Britain's economy and, for the most part, took control of the richest country on earth at the time. But, just as is common these days with corrupt governments that have sold out and corrupt Press organizations that are participating in the overthrows, the treason was made to appear as though it were a move for peace and was in the best interests of the people – and everyone "*acquiesced*" over time.

THE NEW WORLD ORDER – OUR FOREIGN ENEMIES

International banks and other organizations run by the "*global elite*" have been planning, organizing, and incrementally setting up their *New World Order* (NWO) for centuries.

By imploding economies, funding both sides of every war, staging terrorism, and oppressing the masses, they have stolen hundreds-of-trillions of dollars from the other 6-½ billion people on

Earth and their ancestors, much of that from the People of the United States.

Their plan is evil and their tactics are brutal. They are traitors. They are thieves. They are murderers. They are our “*foreign enemies*.” They do not care about our reputation around the world, our sovereignty, our property, our communities, or our families, and they are willing to commit treason and other high-crimes to accomplish their goals.

As alleged in my proposed lawsuits against the traitors, which will be included in my next book, our foreign enemies are either members of the NWO, or are public and private individuals and organizations of foreign lands participating in or profiting from treasonous activities in the United States.

Through the NWO’s *Military Industrial Complex, Federal Reserve System, United Nations, World Bank, World Trade Organization*, and other organizations, the *Illuminati, Bilderberg Group, Council on Foreign Relations, Trilateral Commission*, and other traitors under the veil of the NWO, have taken over many countries; took over Europe and formed the European Union; and took over the United States, Canada, and Mexico over the past few decades and are planning to consolidate them into *their* “*North American Union*.”

MY FELLOW AMERICANS: This is why our borders remained wide open despite 9/11 and other terrorist attacks.

If you were President of the United States of America or a General or a Congressperson on September 11, 2001, what is the very first thing that you would have done? Wouldn't you have secured our borders? And kept them secure for as long as there was a “*War on Terror*”?

In spite of our federal government’s constitutional authority to print our currency, the globalists set up their own *private* Federal Reserve Banking System in our Country, paid off the corrupt factions in our federal government at the time (our *domestic enemies*) to pass the Federal Reserve Act of 1913, and have charged us billions of dollars in extra costs and interest over the past century to print our money.

By controlling our money supply, manipulating our free market system, manipulating our free enterprise system, stealing from our Treasury, and paying off our domestic enemies to rig legislation for such purposes as to collateralize our labor through incrementally increasing income taxes and through the Social Security Act of 1935, to collateralize our private property through incrementally increasing sales and property taxes, to collateralize our National Parks and other public lands with unconstitutional executive orders and treaties, and to overtax businesses and the rich (*their* competitors) to drive them out of our Country, they have stolen the roughly estimated amount of one quadrillion dollars from our ancestors, from us, and from our progeny, have seized control of most of our natural resources, and have slowly enslaved us and many generations to come.

The NWO was behind the Great Depression, incremental over-taxation, the 1987 market crash, the dotcom bubble, the subprime mortgage bubble, the Fannie Mae and Freddie Mac debacle, the 2008 market crash, and the expensive governmental solutions including the “*New Deal*,” NAFTA, and the more recent market stimuli and unconstitutional bailouts of *their* “*too-big-to-fail*” banks. Most Americans believe that the “*banker bailouts*” totaled \$700 billion dollars when, in actuality, the traitors stole over 23 *trillion* dollars from us in that one scandal alone.

MY FELLOW AMERICANS: Are we being set up like the European Union? Take a close look at what has happened in Greece and Egypt – and what is happening in Spain, Portugal, and elsewhere around the globe. Does anyone think the top economists of those countries agreed with the excessive government spending, the bloating of their bureaucracies, and the purposeful implosion of their economies? Have our economists been hoodwinked here in the United States? Not likely; and it does not take an economist to see what is headed our way.

The next time you are in the grocery store, think about the cost of a loaf of bread and a can of corn just five years ago. Is inflation really near zero? The truth is that we are moving further and further into an era of hyperinflation. We are being set up for a huge fall.

The next time you are at the bank, note the interest rates being paid on checking and savings accounts and CDs. Are you and your local hometown bank being ripped off? Do you think the global bankers are earning only 1-2% on your money? The truth is that the NWO's centralized banking system in the United States – known as the “Federal Reserve System,” which, like ObamaCare, was *unduly* codified into law and forced upon the American People – has kept interest rates artificially low for many years, so that the traitors can pay rock-bottom interest rates to us while maximizing their profits in the world economy that they manipulate on a daily basis.

Same with their “quantitative easing” scheme – the \$85 billion per month bond-buying stimulus spree that the Federal Reserve has maintained since the NWO's engineered market crash in 2008 – which is ostensibly to improve our economy, but which in reality is just another money laundering technique.

All of this is theft in the highest order. And the global elite are not only stealing from hard-working Americans, but also from the people of nearly every country on Earth.

Outgoing Federal Reserve Chairman Ben Bernanke and his real bosses don't care about our economy, about jobs, or about anything else they espouse. Monetary policy over the past few decades has been to facilitate the overthrow of the United States.

Commonsense tells us that when the free market finally equalizes itself – likely at the same time that the NWO accomplishes their goal to bankrupt our Country – interest rates will skyrocket, prices will soar, the dollar will become worthless, and civil unrest will ensue, *just like they planned*.

That is, unless we withdraw our consent (*see Chapter 5*) from the *privately-owned* Federal Reserve and grant authority to manage our money to a true governmental organization for the people – for example, to a fourth branch of government.

A large and growing number of Americans and enlightened people all around the world believe that the NWO and their operatives in our government were also behind the devastating attacks on September 11, 2001, and other terrorist attacks and false flag incidents in our Country, in England, in France, in Asia, in the Middle East, and elsewhere.

The NWO has stolen tens-of-trillions of dollars from us to fund *their* World War I and World War II, *their* wars in Korea, Vietnam, Iran, Iraq, and Afghanistan, and now against *their* new enemies in the Middle East and all around the world.

Their history of warmongering is fully documented. Anyone can research and see that our Treasury is being looted and our military is being utilized by the NWO to secure – or rather to steal – land, oil, drugs, and other resources from foreign countries. In fact, warmongering is the NWO's main money laundering technique to cover up their thefts from our Treasury.

In the summer of 2013, they and their operatives in the Pentagon – the *Military Industrial Complex* – tried to convince the Obama administration and Congress that the United States should, like in the Iran Contra and Nicaragua scandals, arm the Syrian “rebels” that were fighting against the thugs placed in power in their country (by the NWO), as part of the NWO's engineered civil war in Syria, which is just a sub-part of a grander plan to keep tensions high in the Middle East, as the NWO positions itself for maximum theft of oil and other resources.

MY FELLOW AMERICANS: The question here is, how long will we Americans continue to fall for the duping of our presidents, generals and other high-authorities into funding jihad, al Qaeda, the Muslim Brotherhood, whoever attacked our Embassy in Benghazi, and now the rebels in Syria?

Or, perhaps better questions would be: Are our presidents, generals and other high-authorities really being duped?; Why are President Obama, former Secretary of State Hillary Clinton, and current Secretary of State John Kerry consistently taking the side of – and even helping – jihads in Libya, Syria, Egypt, Pakistan and elsewhere in the Middle East?; Why in the late summer of 2013 were

President Obama and Senator John McCain and others rushing to arm Syrian rebels and engage our military in Syria's civil war when the rest of the world was staying out of it?; Where is the United Nations in all this?; Why does the United States always have to save the day?; Who are our leaders really working for?; What are the goals?; And, most importantly, are we safer because of the current foreign policies, or because of domestic policies such as the NSA's surveillance of all Americans for that matter?

The NWO and its operatives – *our foreign enemies* – have already taken over our federal government, and, with the help of thousands of traitors in our government, are now working to take control of our states and our local communities.

Their overall mission is to bankrupt the United States and condition us for servitude in their one world government, but their current mission is to spread fear from coast-to-coast in our Country with *their* “*War on Terror*” to prep us for their final assault.

Many believe that the next market crash or terrorist attack in the United States will provide our domestic enemies the impetus to declare “*Martial Law*” for the NWO, utilize our military to disarm us, and begin the mass arrests and “indefinite detention” of millions of Americans that the NWO has been planning for decades.

As the traitors are brought to justice, a great deal more will be written about the NWO its members and its treasonous activities in the United States – in future editions of this book and on the official websites. If you have further information or evidence to prove any overt act of treason by our foreign enemies, you will be able to submit it online soon.

OUR DOMESTIC ENEMIES

Regardless of the treason by our foreign enemies, though, the massive corruption in our other three branches of government, by itself, especially in recent decades, necessitates a fourth branch.

Our “*domestic enemies*” are either NWO operatives here in the United States, many of which have risen to positions of high-authority in our local, state, and federal government offices; or, are government officials and private citizens and organizations of the United States participating in or profiting from “*treasonous crimes*” which adhere to the mission of our foreign enemies.

MY FELLOW AMERICANS: Don't be fooled here. When this book is released, the radical liberals and progressives in our government – the 2% being paid off by the NWO, with our money, to position the United States for takeover – will undoubtedly use *their Mainstream Media* to bash The People's Branch at every turn.

Our domestic enemies will show their true colors, as the vast majority learn of their treasonous crimes and begin to point fingers.

Those with a lot to hide will likely be the most vocal in opposition to our new branch of government.

Our domestic enemies know all about the NWO's treasonous activities in the United States and are aiding in the treason. They know full well that the overall plan is to bankrupt the United States and seize total control of our government, our military, our police and sheriff stations, our hospitals and other healthcare facilities, our transportation hubs, our ports, our airwaves including the Internet, our electric grid, our oil supply, our food and water supplies, our economy, and all other resources.

MY FELLOW AMERICANS: Have you visited your local police and sheriff offices lately? They look like NORAD; they've been militarized; and your local law enforcement officers have been fully trained for “*riot-control*” and “*civil unrest*.”

Did you know that our corrupt Department of Homeland Security (DHS) and Federal Emergency

Management Agency (FEMA) have retrofitted and manned old military bases and other large complexes – now being referred to by patriots as “*FEMA Detention Camps*” – to hold an estimated 40 million Americans, have stockpiled millions of plastic coffins all across the United States, and have stockpiled billions of hollow-point bullets, which they claim are for target practice?

Did you know that DHS's Transportation Safety Administration (TSA) – the agency at our airports that has not arrested a single terrorist since 9/11 – is already gearing up to *unconstitutionally* demand your papers, frisk you and grope your children at bus stations, train stations, sports stadiums, shopping malls, and other locations?

There is absolutely no doubt that these things are being set up for the NWO and that these government offices and many others will be turned against the American People when the NWO makes its final assault to completely takeover our Country.

Research Adolf Hitler's “*Third Reich*” and “*Holocaust.*”

If the NWO is successful, door-to-door gun confiscations and millions of unlawful arrests will follow. Martial Law will not protect us; instead, our domestic enemies will use it to control us for the NWO.

THE REALITY OF WAR AND PEACE:

We, the American People, have a right to peace. And we have been entitled to a formal declaration of peace since World War II.

But instead, our leaders have allowed our military to be engaged in war after war after war, without a declaration by Congress to do so. The Pentagon and Department of Defense have knowingly allowed the Military Industrial Complex to use our money and military for decades to run the NWO's wars all around the globe.

MY FELLOW AMERICANS: War is the biggest business in the history of mankind.

Arms dealing is a huge money maker for all involved, and our foreign and domestic enemies have the largest sales force in the world, which is known as the “CIA.”

Our leaders know full well that the “*War on Drugs*” and the “*War on Terror*” are farces invented by the NWO. With taxpayer money, drug dealers and terrorists are supplied and armed for perpetual war. Can you see the money-laundering?

These “*wars*” have been very expensive for the American People and the more we hear that weapons are being exported and drugs are being imported, even on military vehicles, right under the noses of our leaders, the more we can and *should* infer that our military has been taken over by the NWO and that our leaders are defrauding us into funding not only the NWO's wars, but also their arms dealing and drug dealing in our Country and around the world.

No American should ever be fooled again by the scandals that surface, such as Iran Contra, Nicaragua Contra, and “*Fast & Furious.*”

The Pentagon and the rest of our Department of Defense march on the orders of the NWO, not the commander-in-chief.

Military bases are still being built overseas at a feverish pace. These bases aren't for us; they're for the NWO's *one world government*. And the bases are not temporary as reported – the construction proves that they are permanent, *as planned*.

Under our flag, the NWO fights its wars; and they have an ever-expanding military presence all around the world. But the United States gets the black-eye overseas for stealing private land, and oppressing and harassing the local people.

More and more these days we hear of the Pentagon, the DOJ, the FBI, the NSA and other federal agencies acting outside their authority, even blatantly illegally, and coming together to surveil the American People, and to practice military drills with local law enforcement and set up road blocks and other control tactics in violation of “*Posse Comitatus.*” We hear of DHS classifications of veterans, gun-owners, constitutionalists, Christians, pro-lifers, and supporters

of Obama's political adversaries, as terrorists. We hear of more and more gun control legislation that violates the 2nd Amendment while ignoring the real problems of mental illness and the government's ill-fated solution to prescribe psychotropic drugs and other ineffective treatment to anyone seeking help for a mental problem. We hear of the Pentagon and DOJ ganging up on whistleblowers for "disclosing military secrets" knowing full well that it is their corruption that is being exposed. And more recently we began hearing about the NSA's secret and illegal programs to gather massive amounts of data on *all* Americans.

MY FELLOW AMERICANS: Is this posturing the biggest betrayal of all? What is behind the concern about civil unrest? Why would a government need "metadata" on its own citizens, and is that all they're collecting? Who is really monitoring us? Will the United States be the battleground for the NWO's next war?

When NSA whistleblower Edward Snowden exposed the illegal surveillance tactics of our Department of Defense in the summer of 2013, he was immediately labeled a traitor by many high-officials, but millions – all around the world – called him a hero.

No one in our government expressed any outrage or concern or even any duty to look into the crimes committed by the *real* traitors in our government, now exposed by the evidence Snowden leaked to his *real* bosses – the American People.

The Obama administration urged other countries to follow our "Rule of Law" and arrest Snowden, while hiding their intent to deny Snowden the part of the Rule of Law relating to the protection of whistleblowers.

Our corrupt Attorney General threatened the death penalty.

All involved know that the charges against Snowden are illegitimate, and also know that if he turns himself in or is eventually caught, he will undoubtedly be unlawfully detained, denied justice, tortured, and drugged until he's dead. And then the Press will report another unfortunate suicide.

We need to remember, now and always, that the NWO and its operatives in our government are experts in treason. What often lies on the surface – or what is reported to us by the NWO's Mainstream Media – may appear to be in our best interests or for national security, but underneath is just another step in the set up of the overthrow of our nation.

These government actions, and thousands of others, as is becoming known, were engineered by the NWO; and they can only mean one thing: our domestic enemies are in on the treason.

The next time a scandal surfaces, think of what lies below the surface.

We will never have true peace in our Country until we band together to remove the wicked from power.

OUR COMMANDERS-IN-CHIEF:

Over the past century, our leaders have increasingly aligned themselves with the NWO and its objectives.

Our Presidents and other high-ranking officials have been hinting about a "New World Order" for decades. President George H.W. Bush touted it in his speeches. Henry Kissinger and many others now unabashedly proclaim it every chance they get. Every time we hear a news report about global governance, global currency, global religion, global terrorism, global warming, global taxation and the like, our domestic enemies make another subliminal plug for the NWO.

Bill Clinton's North American Free Trade Agreement (NAFTA) in 1994, which everyone now admits was a huge mistake, aided the NWO in their treasonous secret plan to join the United States with Mexico and Canada to make up one of the regions of their one world government, to be known as the *North American Union*.

In 1999, Congress repealed the Glass-Steagall Act – a very important protection separating investment banking from commercial banking – which, along with other sabotages of our free

market system, opened the door for the NWO to takeover Wall Street.

Apparently, at least to a growing number of people worldwide who are waking up to the NWO's treasonous tactics, *Desert Storm* and the *War on Terror* were launched, at least in part, by Bush Sr. and Bush Jr., respectively, to aid the NWO in their continuing thefts of oil and other property in the Middle East; and, what is really disgraceful about this, and all other undeclared wars, is that our money is being used to fund the NWO's terrorism and treason all around the world.

Traitors in Congress granted the Presidency dictatorial powers following 9/11 with the passage of the "Authorization for Use of Military Force" and other "anti-terror legislation," and made secret arrest and indefinite detention legal in December 2012 with the passage of the National Defense Authorization Act (NDAA). Our presidents can now arrest and indefinitely detain Americans without charge or trial and can assassinate anyone they deem a terrorist, which, according to DHS, may include Ron Paul supporters, libertarians, constitutionalists, those who question or protest war, and those who own gold or stock up on food.

Those who have actually read Patriot Act I – which became the law of our land in the heat of the moment shortly after 9/11 and which was admittedly *not* read by most of the 357 representatives and 98 senators who voted for it – allege conspiracies – in this and other anti-terror legislation at the time – between the progressives in the Bush administration and Congress, to use the 9/11 tragedy to erode our civil liberties for the NWO. And the grossly unconstitutional NDAA points to another conspiracy between the Obama administration and the current Congress to continue usurping our constitution under the guise of national security.

MY FELLOW AMERICANS: This is what I refer to as "legislation rigging" later in this chapter.

All reasonable Americans (and hopefully all jurors in the upcoming criminal trials) will be able to infer that the legislation rigging was done to aid in the treason against the United States.

President George W. Bush, Vice President Dick Cheney, and many high-ranking officials at the CIA, the Pentagon and other federal agencies, *allegedly* had prior knowledge of the plan of attack on 9/11 and could have taken a number of actions to prevent it. But instead, someone, *allegedly* Cheney, ordered NORAD to stand-down during the attacks.

MY FELLOW AMERICANS: If true, Bush, Cheney, and every official at NORAD and the Pentagon who knew about either crime should be indicted for treason; and every reporter and news outlet that knowingly failed to report these key facts, or spread disinformation to help in the cover-up, should also be prosecuted to the fullest extent of our laws.

We supposedly have the most powerful and efficient military in history. So when four airliners turned off their transponders and began crashing into buildings, weren't there hundreds if not thousands of government officials trained to take action?

And why all the secrecy following 9/11? Don't we, especially the families of the victims, have the right to straight answers during investigations?

Do we really believe, as a nation, that 19 expendable idiots from Saudi Arabia could have pulled off 9/11? Or did it take hundreds if not thousands of people spending millions if not billions of dollars over many months if not many years to plan and carry out the attacks?

Why was no one held accountable? Or fired? Or even demoted?

And, what about Bush's eight years as our president? Was he really a republican? Or did he defraud the American People to gain the presidency and then – *for the NWO* – grossly expand our federal government like a radically progressive liberal, promote massive overspending, knowingly allow the Fannie Mae and Freddie Mack scandals and other market manipulations, and set us up for the 2008 market crash?

If you are a Bush supporter like I was, please do not be offended; these are just questions. And I have many more for our commanders-in-chief, military leaders, congresspersons, and other federal

officials, especially regarding their true relationships to those setting up a one world government and their knowledge of the NWO's treasonous activities in our Country.

And now President Barack Obama appears to be aiding our foreign and domestic enemies.

MY FELLOW AMERICANS: Did Obama, like the Bushes and Clinton before him, defraud the American people with phony platforms and promises – twice – to gain the presidency?

What was his true relationship to the now defunct *Association of Community Organizations for Reform Now* (ACORN) and the NWO's multi-billion dollar election rigging industry? Did he and Hillary Clinton meet with the *Bilderberg Group* right after he won the democratic primary in 2008? (Do you remember? He duped the Press onto a plane and then disappeared with Hillary for a couple days.) And what was the meeting about?

Did he lie about ObamaCare to sneak it through Congress and to gain a second term as our president? Is it becoming more and more evident that he never intended to fulfill his campaign promises or to “preserve, protect and defend” our Constitution as he is sworn to do? Is he purposely overspending to bankrupt the United States? Why is he hellbent to socialize our Country?

Once again, please do not be offended. I just have questions.

President Obama claims to not know anything about the many scandals that have surfaced during his presidency, but the simple fact that he is briefed on everything of importance means that he at least knew that criminals at the IRS had been discriminating against his political opponents for years; that he at least knew that criminals in the Attorney General's office and elsewhere at the Department of Justice had been running guns to Mexican drug cartels for years and were illegally monitoring reporters who were looking into such matters or who were critical of his administration's other shenanigans; that he at least knew that despite the warnings and cries for help from Benghazi, just like on 9/11/01, our Department of Defense was standing down during another terrorist attack; that he at least knew that criminals at the NSA were spying on Americans; that he played at least some role in the “Louisiana Purchase” and the “Cornhusker Kickback” and other bribery scandals to obtain passage of ObamaCare, and that he lied, repeatedly, for years, to the American People about keeping doctors and health plans knowing full well that millions would lose them when ObamaCare was implemented.

President Obama has been in Washington D.C. long enough to at least know that many of our leaders have sold out to the NWO and could not care less about our Country.

An increasing and alarming number of high-ranking U.S. officials over the past century, including our presidents, have known all about the NWO and their operatives infiltrated into our government, about their thefts from our Treasury and about many of their other treasonous crimes; but, in conspiracy with the radically liberal and corrupt Mainstream Media, have kept us in the dark or have misinformed and outright lied to us to cover up the treason.

Today, because our presidents and their administrations have knowingly looked the other way for decades, criminal factions – sponsored by the NWO and funded with our money – have been infiltrated into nearly every federal office and into many of our state and local offices as well.

THE REAL CENTRAL INTELLIGENCE AGENCY:

During his presidency, Harry Truman, who had ended World War II in the summer of 1945 with the atomic bombings of Hiroshima and Nagasaki, likened the newly formed Central Intelligence Agency (CIA) to the Gestapo.

In his final address, President Eisenhower forewarned of the “Military Industrial Complex” and of “misplaced power.”

In 1953, apparently on orders of the Military Industrial Complex, which, with our money, has made a business of war for the NWO, the CIA overthrew the democratic government in Iran and its President Mosaddegh to usher in a dictatorship under the Shah of Iran so that British

Petroleum and American Oil could more easily tap into the oil reserves in the Middle East.

High-ranking officials at the CIA, the FBI, the Pentagon, and the White House knew in the 1990s about the connection between Osama bin Laden, Khalid Sheikh Mohammed, and Mohammed Atta, and about their “Planes Operation,” which investigators knew was a plan to hijack airliners and fly them into tall buildings in the United States.

MY FELLOW AMERICANS: It is also becoming known that the Bush family and the bin Laden family had business ties for years through defense contractors and investors, such as the private investment bank known as the Carlyle Group; and that many in American politics and in the military were ignoring the obvious conflicts of interest, both before 9/11 and after, so they could profit from the (not-so-fierce) competition for defense contracts, i.e. so they could profit from the upcoming attacks on 9/11 and the aftermath that would follow.

Prior knowledge was never really investigated.

All involved also knew that thousands of American troops had been moved to the Afghanistan border prior to the attacks, and that the Pentagon and its defense contractors – many of which routinely received no-bid contracts from our government – were mobilizing to the region and were readying for the pending military base building boom.

There is no doubt about the prior knowledge of 9/11 by many in our government; and there is no doubt about the fact that the NWO and its Military Industrial Complex have been stealing from us for years – through *their* Federal Reserve System – to fund their terrorist attacks and false flag incidents in the United States and all around the world.

The CIA had allegedly invented the term “al Qaeda” in the 1980s, had armed bin Laden and his rebels, and had helped conceal their whereabouts for years, all for the NWO.

In 2000, military lawyers prevented the CIA from passing along intelligence on Atta and at least 3 other suspected terrorists to the FBI.

A CIA agent allegedly visited bin Laden in July 2001 during his 10-days in an American hospital in Dubai, but despite bin Laden’s declaration of war against the United States and over 50 intercepted messages of his plans, which were carried out two months later on 9/11, and despite President Clinton’s standing order to arrest bin Laden for his role in the attacks on our embassies and the U.S.S. Cole, the CIA agent failed to do his duties and the CIA as a whole failed to follow up on this and other close encounters.

MY FELLOW AMERICANS: The question here is: Was the CIA’s negligence intentional?

It appears so. In fact, the CIA has a very checkered past.

Since its founding in 1947, the CIA has seemed to be a puppet for the NWO. They wreak havoc around the globe; they incite violence; they provoke war; they frame; they torture.

The CIA’s motto is, “*And ye shall know the truth and the truth shall set you free*” (John 8:32, NAB), but their leaders’ motives and actions have been far from biblically based; many if not most of their leaders’ motives and actions from the start have been evil.

The CIA probably has done some good in the world, but at the time of this writing nothing comes to mind and search engines are of no help either.

THE REAL FEDERAL BUREAU OF INVESTIGATION:

The FBI, too, has, at the very least, lost its way. Its motto is, “*Fidelity, Bravery, Integrity,*” but its leaders seem to encourage just the opposite.

Over the years since its inception in 1908, FBI leadership has steered this agency away from its mission. And today this organization, the National Security Agency (NSA) and other domestic intelligence contractors are allegedly ignoring the limitations of the Patriot Act and other anti-terrorism legislation and due process – and are encouraging local and state law enforcement to do

likewise – to spy on Americans and gather massive amounts of data for the NWO. In fact, many federal agencies and defense contractors appear to be consistently doing the dirty work of the NWO in the United States.

According to reliable sources, the FBI had prior knowledge of the first attack on the World Trade Center in 1993 and actually paid one of the repenting terrorists to proceed with their plan.

Following the 1995 Oklahoma City Bombing, the FBI teamed up with the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) – another wayward agency of the Department of Justice – to cover up the facts that there were multiple bombs planted in the Murrah Federal Building and at least one of them exploded right after the Ryder truck blew up; that the truck bomb could not have brought the front of the building down by itself; that the building blew more out than in; that 12 video cameras not only captured the explosions but also confirmed that Timothy McVeigh was accompanied in the Ryder truck by someone of Middle Eastern descent; and that 19 ATF agents and their staff were paged or otherwise notified not to come to work just before the bombing.

Following the attacks on 9/11, the FBI, who was responsible for the crime scene evidence, allowed the *chemically-compromised* steel and *pulverized* concrete to be trucked away and shipped overseas.

MY FELLOW AMERICANS: Do your own research on 9/11.

Watch the YouTube videos over and over. See for yourself the plumes of smoke coming out of the floors below the falling buildings; hear the testimony of multiple witnesses who heard and felt explosions on many floors of both towers, even on the floors below grade, who saw the pools of molten steel during clean up, which could only have resulted from a chemical reaction of materials applied to the beams during weeks and possibly months before the attacks, and who witnessed many other telling things. See also how the buildings came down at near free-fall speed.

I am not an architect or engineer, but I was good at mathematics and physics in school and was a building contractor for years, and I have many questions: Wouldn't the buildings have pancaked or fallen off to one side or another? Shouldn't the scene have looked like the pancaked bridges and buildings in Oakland following the 1992 earthquake? How were thousands of tons of concrete floors, imbedded with steel, pulverized to dust and blown out horizontally over 500 feet in all directions as the buildings fell? How did the interior core – which housed the elevators and which was designed to be structurally independent of the concrete floors and perimeter wall supports – fall at free-fall speed with the rest. How was very thick steel melted by jet fuel? Doesn't thick black smoke mean the fire is going out? Why was building #7 brought down, which was not struck by either plane and only had a couple of isolated fires, and how was the complicated demolition set up within just a few hours? Why was the evidence disposed of and who ordered that?

Why is everything “*classified*”? And why all the secrecy?

In addition to allowing the crime scene evidence to be removed from the United States, the FBI allegedly picked up both “black boxes” (the airliners’ voice recorders), then pretended as though they were lost, and then refused to allow the 9/11 Commission and the American People hear the tapes.

And no one investigated who ordered NORAD to stand down during the most devastating terrorist attack in history.

The FBI’s secrecy and questionable handling of the fake terror plots by the “shoe bomber” and the “underwear bomber” also show that they are not even working for us anymore.

And who can forget the FBI’s incompetence in Waco and their role in the massacre of the Branch Davidians?

MY FELLOW AMERICANS: This is not to say that the CIA and FBI are corrupt through and through. In fact, article after article show that most of the 56,000 employees are doing an exemplary

job.

But the conspiracies and blunders cannot be denied; and neither can what appears to be outright treachery and treason. And so, we can only assume that the leadership is corrupt; that the wicked have truly risen to the top and have formed criminal factions within our government to carry out the treasonous plots of the NWO.

The CIA's and FBI's histories will take a turn for the better when their investigative and intelligence gathering arms are transferred to The People's Branch.

When The People's Branch is established, the new and improved CIA and FBI agencies will painstakingly investigate the flow of money, arms and drugs in and out of our Country.

We – through our CIA, FBI, PSA, PDI, PODI, POFI, etc. – will seek the truth about the above-mentioned scandals; about 9/11 and other so-called terrorist attacks; and about the terms of the recent agreement or treaty that required the United States to *give* 29 F-16s and 200 Abrams tanks to Egypt, which is now under the control of the Muslim Brotherhood, a group with evil designs against the United States, Israel and other allies.

OTHER WAYWARD AGENCIES:

Due to the increasing – and intentional – misrepresentation, mismanagement, lack of leadership, official negligence, official misconduct and unaccountability all across the United States over the past several decades, our government is filled with lawless individuals who are either directly involved in the treason or who use their offices to racketeer, to gain favors for special interests, and even to harass those they hate.

Criminal factions have been infiltrated into nearly every federal office and many of our state and local offices as well, where the 2% seek to control the 98% for the NWO.

MY FELLOW AMERICANS: As you know, volumes of books could be written on the scandals that take place in our government offices each year.

This section explains a few and the latter half of this chapter goes into great detail regarding the treasonous crimes being committed from coast-to-coast, especially in the judicial branch where officers of our courts are fixing court cases for profit in many of our 180,000 local communities.

What is important to grasp here is that for every scandal exposed by our very liberal Press there are likely – even in small communities – hundreds that never see the light of day.

The highest officials in most state and federal governments know all about the “case fixing” in our courts, the “legislation rigging” by our lawmakers, the racketeering by our law enforcers, and the cooking of the books by our executives to increase federal funding, but they look the other way so they can ask Congress for larger and larger appropriations each year.

The next time you hear about a city or county official embezzling or engaging in any corrupt act, assume that many others are involved and many other crimes are being committed.

Become a private sleuth in your community. Form a task force. Examine the books back 20-30 years. Follow the money. See who's skimming from public funds, or sponsoring sports teams, paying for Billy's braces, traveling to exotic places, or investing in the NWO's derivatives and credit default swaps with the people's money.

And then, report it to your local Director when The People's Branch is up and running.

The United States Department of Health and Human Services (DHHS), which advises on its website that it “is the principal agency for protecting the health of all Americans,” would more accurately depict its current mission if it were renamed the “*Department of Women's Health and Services.*”

MY FELLOW AMERICANS: This is not to say that all who work at DHHS are anti-male, but there is no denying the fact that this department and its divisions have become melting pots for feminists, ranging from the mild to the hardcore; from the gals who simply want equal rights to the militant who will do and say anything for special rights; from the happily married to the opportunistic gold-diggers; from the unfortunately divorced to the malicious single moms keeping fathers away from

their kids and using their offices and connections to oppress their ex.

Just like the movements for civil rights and abortion rights and gay rights, the NWO *invented* feminism, as part of their strategy to divide and conquer us. And we will pay for the hate mongering at DHHS until we wise up.

Please do not take offense here either. I, and most other father's rights advocates, have great respect for the feminists of old who gained equal rights a few decades ago; we applaud them, but despise the hardcore feminists and other pathetic special interest groups who are pursuing *special* rights for women, are willing to defraud state and federal legislators about domestic violence and "*deadbeat dads*" to get what they want, and are encouraging false accusations and hatred against men all across the United States for unfair gain in divorce and other family law matters.

My point is that every group has its traitors.

In the frenzied pursuit of extra federal funding, millions of noncustodial parents, mainly fathers but some mothers too, have been ripped off by Child Support Enforcement (CSE) and Child Protective Services (CPS) officials operating under the oppressive mandates of DHHS's Administration for Children and Families (ACF). Verifiable evidence already exists to prove that widespread fraud and discrimination against noncustodial parents is practiced by many CSE offices, that children from good families are being kidnapped for foster care funding and that malicious single moms are being assisted in their crimes by CPS offices, and that massive and systemic cheating of the various taxpayer funded entitlement programs associated with family law and the criminal justice system is taking place all across the United States.

The Food and Drug Administration (FDA) is also under the veil of DHHS. Why the two specialties are regulated by the same agency is uncertain, but it is clear that food conglomerates and drug companies are allowed to monopolize in their field and experiment with their new creations in the mass-market.

MY FELLOW AMERICANS: I am not an expert here, but believe what other patriots say about the FDA.

Paying off the FDA is just another cost of doing business for "Big Pharma" and "Big Agra."

The NWO and its food supplier members invent new unpronounceable chemicals and supplements that will increase our cravings for their genetically modified and processed foods and elixirs, and the FDA teams up with state legislators and local law enforcement in some areas to run organic farms out of business.

The NWO and its drug company members defraud the American People with scams about high cholesterol and ADHD and H1N1, and solve the resulting crises with Lipitor and Ritalin and tainted flu virus vaccines, all laced with chemicals that will produce other desired harmful effects, and the FDA looks the other way.

There is no doubt that the epidemics of obesity, diabetes, heart disease, Aids, ADHD, ADD, Autism, mental illness, depression, H1N1 and other flu epidemics, were all *engineered* by the NWO and there is no doubt that the governmental *solutions* to all these epidemics are designed by our domestic enemies to benefit the NWO's members.

Sure, we are living significantly longer today than just a century ago, but I'm likely not the only one that wonders how long we would be living, with the best healthcare on earth, if we weren't being poisoned by the traitors.

On its website, DHHS claims to represent "almost a quarter of all federal outlays." DHHS is the largest government agency in the United States and is also the most wasteful and corrupt. It has become an enormous oppressive bureaucracy and is currently staffing up even more, right along with the IRS, for the administration and enforcement of ObamaCare.

MY FELLOW AMERICANS: According to their websites, DHHS employs over 65,000 people and has an annual budget of over \$700 billion and the IRS employs over 100,000 people and has an annual budget of about \$13 billion.

Both agencies were purposely overgrown for the NWO and, if martial law is ever declared, both will play an active role in controlling the masses.

The criminal factions within the DHHS will continue duping vaccines, poisoning our food and water supplies, and falsely testifying against parents to aid the NWO in breaking down the family unit; the criminal factions within the IRS will continue delaying, profiling, targeting, discriminating against, and testifying against the NWO's political enemies, patriots, dissenters, protesters, and anyone else who would dare to stand up to the traitors; and both agencies will administratively fix cases, falsely accuse, and falsely testify against the poor, the young, the old, and the ignorant, to maximize the incarceration of the masses for the NWO.

And like countless other federal agencies, the IRS and DHHS will continue to do practically anything they want to increase their funding. That is, until The People's Branch is constituted.

The PEOPLE'S DEPARTMENT OF HUMAN SERVICES (PDHS) will do what DHHS does and the PEOPLE'S REVENUE SERVICE (PRS) will do what the IRS does for a small fraction of the cost; but DHHS and IRS employees needn't worry, as there will be plenty of job opportunities both in government and in the private sector.

As shown elsewhere in this book, the IRS, the Securities and Exchange Commission, the Federal Election Commission, and all other offices proposed to be transferred to The People's Branch, are corrupt; and the criminal factions within each office are doing all sorts of things to position their office for the next market crash or terrorist attack, when our domestic enemies will declare martial law, take our guns away, and have our military march our streets awaiting orders to arrest those who will fill up the FEMA Detention Camps.

The one to watch, though, is the Federal Reserve.

Perhaps the most destructive element of the treason committed in our Country since its founding has been the set up of centralized banking in the United States.

MY FELLOW AMERICANS: You will never hear the truth from the Mainstream Media, as long as its owners are members of, or controlled by, the NWO. So spend a little time reading about the Federal Reserve and its private owners online, and see what others say about it. Here are a few quotes to get you started:

“Give me control of a nation's money and I care not who makes it's laws” – *Mayer Amschel Bauer Rothschild*

“This [Federal Reserve Act] establishes the most gigantic trust on earth. When the President [Woodrow Wilson] signs this bill, the invisible government of the monetary power will be legalized ... the worst legislative crime of the ages is perpetrated by this banking and currency bill ... From now on, depressions will be scientifically created.” – (1913) *U.S. Representative Charles A. Lindbergh, Sr.*

“A great industrial nation is controlled by its system of credit. Our system of credit is concentrated in the hands of a few men. We have come to be one of the worst ruled, one of the most completely controlled and dominated governments in the world – no longer a government of free opinion, no longer a government by conviction and vote of the majority, but a government by the opinion and duress of small groups of dominant men.” – (1913) *President Woodrow Wilson* [lamenting passage of the Federal Reserve Act]

“We have, in this country, one of the most corrupt institutions the world has ever known. I refer to the Federal Reserve Board. This evil institution has impoverished the people of the United States and has practically bankrupted our government. It has done this through the corrupt practices of the moneyed vultures who control it ... There is not a man within the sound of my voice who does not know that this nation is run by international bankers.” – (1932) *U.S. Representative Louis T. McFadden*

“Most Americans have no real understanding of the operation of the international money lenders. The accounts of the Federal Reserve System have never been audited. It operates outside the control of Congress and manipulates the credit of the United States.” – (1979) *U.S. Senator*

Barry Goldwater

“The regional Federal Reserve banks are not government agencies ... but are independent, privately owned and locally controlled corporations.” – *Lewis v. United States*, 680 F.2d 1239, Ninth Circuit 1982

The “*Federal Reserve System*” sounds like a government entity – like it belongs to us – but in actuality it is a *private* bank, owned by members of the NWO. And through *their* Federal Reserve System, the NWO has stolen tens-of-trillions of dollars from our Treasury to fund *their* set up of *their* government, *their* wars, *their* terrorist attacks, *their* sabotages of economies, *their* population reduction tactics, *their* population control tactics, *their* murders and *their* tyranny – all around the world.

And tens-of-thousands of traitors in our own government have aided the NWO in their thefts and takeover plans or have knowingly looked the other way.

If you have further information or evidence to prove any overt act of treason by our domestic enemies, you will be able to submit it online soon.

THE TREASON

It is important that all Americans understand that we are far past just a threat of overthrow – the United States and many of our 50 states and 180,000 local communities have been taken over by the NWO and we are being set up for bankruptcy, martial law, enslavement, and the total collapse of our society.

Our foreign and domestic enemies are in control of our Country, our government, our military, our law enforcement, our courts, our resources, our economy, our lands, our labor, our minds, our culture, our futures, and our very way of life.

The NWO has also, as confirmed in the previous section, taken control of Wall Street, our money supply, our credit rating, our currency, and all other monetary concerns.

- Propaganda, disinformation and outright fraud by the Press;
- Communism, fascism and totalitarianism in our Country;
- The Federal Reserve Act of 1913 and centralized banking;
- The Great Depression and every market crash since;
- Massive public debt;
- Massive private debt;

- The Savings & Loan Debacle;
- The Fannie Mae and Freddie Mac debacles;
- The Troubled Asset Relief Program (the “Banker Bailouts”);
- The Emergency Economic Stabilization Act of 2008;
- The American Recovery and Reinvestment Act of 2009;
- The Patient Protection and Affordable Care Act (ObamaCare);
- Loss of doctors and “grandfather” status in ObamaCare;
- Loss of millions of individual and group health insurance plans;
- The “Fiscal Cliff,” the sequesters, the threat of default (during shutdown), and other frauds to cause false alarm;
- Subsidies for the rich and no-bid contracts for friends;
- Massive fraud and waste by our government;
- Massive bureaucratization of our government outside its constitutional limits;
- Intentional lack of leadership, official negligence, official misconduct and unaccountability;
- The “Legislation Rigging Industry” and thousands of unconstitutional laws, rules, orders, and policies;
- The “Election Rigging Industry” and thousands of fixed elections to infiltrate our government;
- “Judicial activism” and “case fixing”; and the broken families and other aftermath of millions of fixed court cases;
- The “Divorce Industry,” the high divorce rate, “planned” parenthood, single motherhood and fatherlessness;
- The “Prison Industry,” over-charging, over-sentencing, over-fining. and the framing and incarceration of the innocent;
- *Roe v. Wade*, the “Abortion Industry,” eugenics, sterilization, and other population reduction tactics;
- The attacks on the family, on homeschoolers, on Christians, etc;
- Impunity and immunity for the evildoers;
- The militarization of our police and sheriff departments;
- The over-criminalization of state and federal laws;
- The set up of FEMA Detention Camps and the stockpiling of millions of coffins and billions of bullets;
- Oppression, division, civil unrest, domestic violence, domestic terrorism, etc.;
- Discrimination against minorities, women, and now fathers;
- Feminism; and now hardcore militant feminism;
- The ‘coming out of the closet’ of gays; and now hardcore militant homosexuality;
- Hate-mongering, fear-mongering, hopelessness and despair;
- Assassination, murder and induced suicide;
- Poverty; and dependence on food stamps, other ‘entitlements,’ and now health insurance subsidies;
- The “Big Pharma” and “Big Agra” monopolies;
- The cholesterol scam and misdiagnoses of high-cholesterol for Big Pharma;
- The mental illness and depression epidemics, and the anti-depressant drug solution;
- The ADHD, ADD, and Autism epidemics, and the psychotropic drug solution;
- The H1N1 virus and other phoney flu epidemics; and the duping of vaccines;
- Excessive MSG, high-fructose corn syrup, and other addictive additives for Big-Agra;
- Obesity, diabetes, heart disease, aids, and other lifetime reduction tactics;
- Genetically modified foods, animals and plants;
- The incremental poisoning of our food, water, and air supplies;

- The Theory of Evolution;
- The Separation of Church and State;
- The removal of God from all aspects of our culture;
- The moral degradation of our society;
- Atheism; and now hardcore militant atheism;
- The global warming hoax; and the “carbon tax” and “cap and trade” solutions;
- The intentional dumbing down of generations of Americans in our public schools;
- Manipulation of university and college courses and curriculums;

Each of the foregoing is an overt act of treason against us, or was done to knowingly aid in the overall takeover plan.

In the incremental treason described above, notice the trend: First, our foreign enemies create a problem in our Country, then our domestic enemies offer a governmental solution, and finally our rights are compromised while the traitors expand their control. For example, the NWO funded their rebels known as al Qaeda to attack us on 9/11, the Bush administration launched their fraudulent “War on Terror,” and – to keep us safe – the NSA was empowered to spy on us and the TSA was empowered to grope us, our children and even elderly people in wheelchairs at our airports.

Today, nearly every facet of our society is rigged by the NWO in preparation of their final push to take total control of the United States. We live in a matrix of deceit created by the NWO and its Mainstream Media. Reality is unknown to us. Truth has been cast aside in every element of our existence so that a few can satisfy their lust for power and domination.

As the traitors are brought to justice, though, we Americans will slowly pull our heads out of the sand, open our eyes and ears, and come to understand how the wicked rose to the top and how we can take back our Country. And fortunately for us, even as daunting as the task appears, our Founding Fathers gave us the answer to tyranny in the Declaration of Independence and gave us the authority to address the treason in our Constitution.

The Constitution of the United States, Section 3, Article III, states in part:

“Treason against the United States shall consist only in levying War against them, or in adhering to their Enemies, giving them Aid and Comfort. No Person shall be convicted of Treason unless on the Testimony of two Witnesses to the same overt Act, or on Confession in open Court.”

The law is simple. And since the facts are irrefutable and the evidence cannot be rebutted, it will be proven that the traitors are either warring against the United States directly or are giving aid and comfort to our foreign and domestic enemies.

MY FELLOW AMERICANS: The real beauty of our Constitution, like the Bible, will begin to manifest when the traitors begin to fall into the pit they dug for us – when they begin to bash The People’s Branch and when they point the finger at their cohorts, their victims, the just and righteous and innocent; when they spew their filth, kick and scream, and flail and grind their teeth, as they are being hauled off to their FEMA Camps or to the gallows.

In other words, they will convict themselves with their words and actions, and We the People of the United States will know who the traitors are by their reactions to The People’s Branch and to our civil and criminal complaints against them.

More on this in *Chapter 6*.

The treason will end as soon as The People’s Branch is established.

All Americans are victims of the treason and will have an opportunity in the near future to fill out an “Affidavit of Damages” to claim their share, but first, everyone should do what they can to support our new branch of government – see Chapters 5 & 6.

TREASONOUS CRIMES

In addition to increasingly, and more openly, committing overt acts of treason, the NWO's operatives infiltrated into our local, state and federal governments, and our other domestic enemies, committed millions of "*treasonous crimes*" against the masses in recent decades to weaken our society in preparation of the takeover, or for profit in their own racketeering schemes.

With impunity, our domestic enemies in Congress and in our state assemblies "*rigged legislation*" for the NWO and its hundreds of special interest groups with treasonous agendas; introduced and passed known unconstitutional laws designed for the NWO by the *American Legislative Exchange Council* and other traitor organizations; and engaged in insider trading, accepted bribes, and accepted lifetime salaries and other illegal enrichments, all of which are ways the NWO pays off its operatives and launders its thefts from our Treasury.

With impunity, our domestic enemies with ACORN and other traitor organizations within the United States – and even within the Democratic Party and Republican Party – "*rigged elections*" for the NWO, and intimidated and discriminated against voters.

With impunity, for the NWO and for extra profits and taxpayer funding, tens-of-thousands of corrupt officers and cronies of our state and federal courts all across the United States "*churned*" and "*fixed*" millions of court cases against the poor, the young, the old, the ignorant, the "*pro se*," noncustodial parents, child support debtors, and civil and criminal defendants; broke apart millions of American families; racketeered and extorted billions of dollars from their victims; took billions of dollars in bribes, kickbacks, payoffs and the like; over-charged, over-fined and over-sentenced millions of defendants; imprisoned thousands of innocent people; cheated the American People out of hundreds-of-billions of dollars through our entitlement programs associated with family law and the criminal justice system; and funneled hundreds-of-billions more into the NWO's "*Divorce Industry*" and "*Prison Industry*."

And with impunity, tens-of-thousands of corrupt law enforcement and child support enforcement officials, corrections officials, parole and probation agents, public defenders and 'treatment' specialists, and other traitors, participated in the case fixing and racketeering, made false arrests, intimidated defendants into unfair plea deals, obstructed justice, and criminally neglected their duties, to give impunity and other aid to the case fixers and to fill up and maintain maximum capacity in our jails and prisons for extra federal funding; cheated the American People out of hundreds-of-billions of dollars through our criminal justice system and funneled hundreds-of-billions more into the NWO's Divorce and Prison Industries; while all involved knowingly carried out the dirty work of the NWO in our local communities.

LEGISLATION RIGGING:

Our local, state, and federal law registers are packed with unconstitutional laws and rules to benefit the NWO, i.e. to weaken our society; or to benefit the NWO's operatives, i.e. to increase profits at Big Pharma, Big Agra, and other businesses carrying out their treasonous mission in the United States.

MY FELLOW AMERICANS: Thousands of unconstitutional laws and rulings and policies have been entered upon our books by corrupt lawmakers, judges, and executives.

But do not worry. The People's Branch will "have the power to abolish, repeal, or declare void, any arbitrary or unconstitutional law, rule, order, policy, treaty or action, if not timely addressed by the other three branches." *People's Branch Amendment, Section 2*

In this section, two "laws" – namely "*Roe v. Wade*" and "*ObamaCare*" – are presented. Both are illegitimate, but were knowingly forced upon us with the intent to acquire our "acquiescence"

over time, which worked beautifully in the former as part of the NWO's population reduction strategy in America and will work in the latter to redistribute one-sixth of our economy to the NWO if we do not wake up soon.

ROE v. WADE – THE “RIGHT” TO KILL: One of the most devastating acts of treason against our Country was the legalization of abortion in *Roe v. Wade*, which has resulted in the murders of over 55 million Americans to date.

United States Supreme Court Justice Harry Blackmun ruled in *Roe v. Wade* and wrote the federal statute legalizing abortion, knowing full well that he was acting outside his authority. He and the rest of the majority knew that only Congress has the constitutional authority to make law, pursuant to Article I, Section 1 of our Constitution, which clearly and concisely states, “All legislative powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.”

They knew that the High-Court was being defrauded by proponents of an unconstitutional “right to choose.”

They knew that their ruling in *Roe v. Wade* would not be made “in pursuance” of the provisions of our Constitution.

They knew that their statute – *their* law – would violate liberty interests guaranteed by the Constitution, such as the father’s right to the care, custody and companionship of his children, and would violate the familial rights of the mother, father, siblings and relatives; would erode the mother’s right to honest services and accurate information for the maintenance of her healthcare; and would take away the unalienable God-given right to life of the child.

They knew that their law would not serve a legitimate purpose of government.

They knew that they were legalizing murder and manslaughter.

They knew that their ruling would benefit the NWO and would usher in the NWO’s culture of death in America; would harm millions of American mothers, fathers, siblings, and relatives, who have rights to a relationship with all relations including the unborn; and would harm all of society in various ways.

They knew that their ruling would shock the consciences of most Americans, would undermine commonsense and decency, and would jump-start the moral degradation of our society, which has resulted in enormous damages to our entire nation.

They knew that there were better solutions to unwanted pregnancies and that churches and charitable organizations and the soon-to-be pro-life movement were, and still are, more than willing to care for the unwanted and unaffordable babies.

And they knew, as did all the other Justices and many others with the authority to overturn it, that their ruling in *Roe v. Wade* was *automatically* rendered null and void and unenforceable for any one of the foregoing reasons.

MY FELLOW AMERICANS: In addition, anyone in a position of authority, not only judicially but also administratively and legislatively, can, and has a duty to, declare *Roe v. Wade* void.

A law is either valid or invalid. It doesn’t matter if Blackmun and the other corrupt justices were paid off by the NWO, or were promised islands in the Caribbean, or were just evil themselves. All that matters is that they ignored the original meaning of our Constitution, 200 years of American precedence, and several hundred years of English common law, all protecting human life.

For over 40 years, *Roe v. Wade* has been touted as protecting the health and welfare of women but it has done just the opposite. Instead of alleviating the suffering of rape victims, the poor, the scared, and the confused, the “*choice*” to abort a child causes a lifetime of pain and suffering for the parents, siblings, relatives, and all of society.

All of society, especially women and especially those who chose to end the life of their child,

have been injured as follows:

- Fifty-five million children have been deprived their right to life.
- Millions of mothers have suffered from guilt, physical pain, emotional pain and other ills from being hoodwinked, by the father or our government, into killing their child; have suffered the loss of the relationship with their child; and will suffer for the rest of their lives.
- Millions of fathers have suffered from guilt, physical pain, emotional pain and other ills from being hoodwinked into killing a child, or from being left out of the decision altogether; have suffered the loss of the relationship with their child; and will suffer for the rest of their lives.
- Millions of siblings and relatives have suffered from the loss of a relationship with their brother, sister, cousin, or other relative; and will suffer for the rest of their lives.
- All of us have suffered from the loss of tax revenue which would have been received from most of the 55 million murdered Americans had they been allowed to live; we have suffered from the loss of ideas, invention, innovation, enterprise, charity, camaraderie, assistance and time, which would have been enjoyed had they been allowed to live; we have suffered from the stigma of being the only Superpower on Earth to legalize the murder of its own citizens; and we will suffer for the rest of our lives.
- And many generations to come will suffer because of *Roe v. Wade* and our 40 years of *forced acquiescence* to it.

Abortion is one of the NWO's main population reduction tactics. The NWO promotes abortion, eugenics, genocide, suicide, sterilization, poisons in food, water and air supplies, and many other population reduction strategies, all around the world, to weaken societies, as part of their plan to takeover countries and consolidate them into their one world government.

MY FELLOW AMERICANS: Think about it. *Roe v. Wade* is not just unconstitutional; it is evil. It is not good in any way. It is the brainchild of a small minority of international control freaks who seek to depopulate the world for selfish reasons. It does not serve a legitimate purpose of government in *any* nation.

Research: Margaret Sanger and eugenics and the beginnings of “planned parenthood.”

On the “*Georgia Guide Stones*,” the NWO boldly and brazenly sets in stone – in our Country, for all to see – their plan to depopulate and maintain the world's population under 500 million.

MY FELLOW AMERICANS: This is an admission – in writing – by the NWO that they intend to murder 6 billion people on earth. Can it get any more evil than this?

And can you see now how the facts of their evil treasonous plan for America will be proven in a court of law?

Our leaders have known for over 100 years about the NWO's propaganda promoting their population reduction tactics. There is no doubt that the NWO, their operatives in our government, and our domestic enemies, influenced the Supreme Court Justices in 1973 – in some way – to get *Roe v. Wade* on our books.

Our local, state, and federal books are filled with unconstitutional laws and tainted precedence like *Roe v. Wade*. In fact, “*judicial activism*,” which is the politically correct term for “*case fixing*” (see below), and which has become a rampant scourge upon our society by corrupt state and federal judges all across the United States, was *engineered* by the NWO, just like the “Abortion Industry” and the murders of 55 million Americans, feminism and hardcore militant feminism, homosexuality and hardcore militant homosexuality, the “Divorce Industry” and the high divorce rate, domestic violence and domestic violence scams, single parenthood and fatherlessness, poverty and drug abuse, and all other crises in our Country.

But bottom line: Our courts are for resolving controversies in our laws, i.e. for settling disputes. When lower courts err, their decisions are appealed to higher courts – “appellate courts”

– the last stop, the final arbiter, being the United States Supreme Court (USSC). In this case, the USSC had the authority to affirm or reverse the lower court's decision in *Roe v. Wade*, but certainly not to make a law binding millions of Americans to the ideologies of five rogue justices. And therefore, *Roe v. Wade* is void.

OBAMACARE – THE “AFFORDABLE” CARE ACT: The *Patient Protection and Affordable Care Act* (ACA), commonly known as “ObamaCare,” touted as 'President Obama's signature domestic policy achievement,' is an *illegitimate* law.

Among many other fatal errors, our federal government does not have the authority to regulate any private industry, not even under the “general welfare” clause of our Constitution. With the powers granted to Congress, it can only regulate “Commerce [shipping; transport of products and services] with foreign Nations, and among the several states, and with the Indian Tribes,” and Congress cannot make a law that “usurps” [takes illegally or by force] a power belonging to us or the states pursuant to the Tenth Amendment: “The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.”

In addition, as you will learn, like *Roe v. Wade*, ObamaCare does not fulfill a legitimate government purpose; it is a power-grab by our domestic enemies for our foreign enemies; it simply seizes control of the healthcare and health insurance industries for the NWO; it is another link in the NWO's massive control grid, which they have been secretly setting up for decades in preparation of their final assault to totally take control of us.

Under the ACA, *in violation of our laws*, all Americans are mandated to have health insurance and all healthcare plans must cover ten essentials: outpatient services; emergency services; hospitalization; maternity/newborn care; mental health and substance abuse services; prescription drugs; lab services; rehabilitation (for injuries, disabilities and chronic conditions); preventive/wellness programs and chronic disease management; and pediatric services. And while all fine and dandy, our federal government has no authority whatsoever to decide what's best for us or to mandate that we buy their one-size-fits-all plan.

For many of the same reasons that *Roe v. Wade* is invalid, ObamaCare is also *automatically* null and void and unenforceable.

And the real shocking thing here is that Barack Obama was a constitutional law professor before becoming our president.

He knows full well that his bribery of Congresspersons (in the “Louisiana Purchase” and “Cornhusker Kickback”) to obtain passage of ObamaCare, automatically rendered it void.

He knows that the legislation had to emanate from the House, but that Senate Majority Leader Harry Reid circumvented the law to sneak it through the Senate on Christmas Eve in 2009, which rendered it void.

He knows that the insertion of 300 pages into the healthcare bill in the wee hours of the morning on the day of the deciding vote in the House rendered it void.

He knows that Speaker of the House Nancy Pelosi's insistence that “*We have to pass the bill so that you can find out what is in it*” and other statements made to defraud Congress and the American People to obtain passage of ObamaCare, automatically rendered it void.

He knows that *any one* of the votes cast to pass the ACA by Congresspersons who had not read the bill, rendered the law invalid.

He knows that he cannot unilaterally change a law, and that when he granted extensions to big businesses and waivers to his family and friends, he rendered his executive orders and ObamaCare void.

He, and all of Congress, know full well that the function of healthcare belongs to the states

and the people, that the federal government can only regulate the interstate commerce of healthcare, and that by enforcing the bogus Affordable Care Act, he is committing yet another very serious breach of our trust.

And he and his administration and Congress know that continuing to implement ObamaCare despite its invalidity is another massive fraud upon the American People.

MY FELLOW AMERICANS: Let's call it what it is.

ObamaCare is a scheme. It is a redistribution of wealth scheme. It is a 'bait-and-switch' gimmick. It is an artifice to defraud. It was predicated on lies. It is the NWO's takeover of the healthcare and health insurance industries. It is government-sanctioned theft, not only of public and private property, but also of our freedom to choose our own doctors and health insurance plans and of our right to doctor/client privacy. It may be the grandest conspiracy ever perpetuated. Hundreds and perhaps thousands of radically liberal and progressive government officials, business officials, lobbyists, special interest groups, healthcare "professionals," health insurers, bankers, lawyers, subcontractors and others lining up for taxpayer money and easy profits, are in on it.

Although a redistribution of wealth scheme, ObamaCare is not a *socialistic* redistribution to benefit the poor. It is just another way for the NWO to steal from all Americans, poor and rich alike. As stated on a popular cable news program, it is the "forced sharing of American assets."

Some believe the endgame is a "Single Payer System" – another entitlement, "socialized medicine," "universal healthcare," "Medicare for all." But others disagree; they believe that the traitors do not want to be limited to their albeit very lucrative frauds and thefts in other single payer systems like Social Security and Medicare, but also want to continue diverting billions of dollars to their friends and allies in the private sector.

The loss of millions of individual and group health insurance plans was known about and planned by the conspirators (our foreign and domestic enemies), as was the loss of coverage for certain prescriptions, the increase in premiums for most of the middle class, the expansion of Medicaid, and the pending tax hikes to pay for it all. And, although open enrollment just began on October 1, 2013, by mid-November the traitors were already suspiciously talking about bailouts for the health insurance companies that were "forced" to cancel millions of their policies to make way for the ACA, which now appears to have been the goal all along.

There is no doubt that President Obama knew that his promises – that if we liked our doctors and plans, we could keep them, and that the average American family would save \$2500 per year under ObamaCare – were lies, and so did his speechwriters and sources, and so did the Congresspersons and subcontractors that drafted the 2000+ page bill, and so did DHHS Secretary Kathleen Sebelius and her subcontractors that drafted the 50,000+ pages of regulations. The president's broken promises were just part of the scheme. The holders of tens-of-millions of canceled policies will be forced into ObamaCare or will be forced to pay the government's extortionate penalties. Get it? This is tyranny.

There is also no doubt that the criminal factions in our government – the radical liberals and progressives, and the NWO's other operatives – are traitors, but they are not stupid. And, unless we stop them, just like since their takeover of the banking industry in 1913, they will come up with all sorts of ways to utilize ObamaCare to steal from the American People.

We've only seen the very beginning of the scheme.

The 2% say they care about the poor, and don't seem to mind a bit when pundits say they are trying to "fundamentally transform" our nation into a "welfare state," an "entitlement state," or a "nanny state," knowing that nearly 50% of our population is on the government dole in one way or another. The vast majority of Americans do not know that their real agenda is to transform our Country into an oligarchy in which they will rule, the poor will serve them for the scraps from their tables, and we, the working class, will finance their totalitarian utopia.

It is all about power and control. Our enemies have risen to the top and have taken control of our government, and ObamaCare and Food Stamps and other entitlements will buy plenty of votes to keep them there. And trillions of dollars will be taken from the American People and

distributed to the NWO's subcontractors and other operatives to keep the scam running.

MY FELLOW AMERICANS: Put all other concerns aside for a minute and take a look at some simple math:

The sleazy snake oil salespersons that sold us on ObamaCare, plied us with the overriding charitable cause of providing health insurance to the 30 million Americans who could not afford it or who could not get it due to a preexisting condition.

After President Obama signed the ACA into law in March 2010, the truth began to surface. The cost *just* to implement ObamaCare was first estimated in the billions of dollars, then \$1.5 trillion, and is now estimated at \$2.8 trillion.

Had we known this one small part of the monstrous treason that is now known as ObamaCare, most reasonable Americans – and Congresspersons if there are any – would have amended the bill to simply cover the uninsured. For example, let's presume that the average uninsured would have cost us \$500 per month for suitable coverage; so, 30 million people at \$6,000 per year would cost the American taxpayers \$180 billion. Done deal!

Do you see what would have happened if we weren't being lied to the whole time by the masterminds of this brilliant government 'solution'? We would have agreed to simply cover the uninsured. If we had a spare \$2.8 trillion lying around somewhere, we could invest it and, just with the interest earned, pay the \$180 billion in annual premiums into perpetuity.

I don't know about you, but I'm sick and tired of being forced to finance a runaway and out-of-control government, especially now knowing that those in control of the purse strings are traitors. This is just a suggestion, but perhaps we could demand, on new evidence, that Congress repeal ObamaCare, introduce a bill to accomplish the above, and dock the \$180 billion each year from DHHS and the other offices and subcontractors involved in treason.

We the People of the United States should not have to pay for it, and neither should future generations.

In November 2013, DHHS Secretary Kathleen Sebelius testified before Congress regarding the botched rollout of ObamaCare, which requires all Americans to have health *insurance* by March 2014 or face a tax penalty. She said the United States remains the only western country “that doesn't have health *care* as a basic right.” And this is where the scheme begins to unravel.

Health insurance and health care are two separate and completely different things. The President, the DHHS Secretary and most lawmakers know full well that the ill or injured poor, preexisting condition or not, could not be turned away from any healthcare facility. The law already protected the poor.

MY FELLOW AMERICANS: So why does ObamaCare even exist? If anyone in the Obama administration or Congress really cared about the 30 million uninsured Americans, why didn't they just propose a law that mandated insurers and providers to cover them and work it into their costs of doing business?

Because, what they – our domestic enemies – were after, was a legal way to redistribute wealth from the middle class to the ruling class and to their friends running the NWO's companies and special interests in the United States. ObamaCare legalized theft just like *Roe v. Wade* legalized murder. And the whole nation was conned into believing they have a right to health *insurance* – subsidized by taxpayers if unaffordable – just like women were defrauded 40 years ago into believing that they had a right to *choose* the life or death of their unborn.

The question remains whether or not we will “*acquiesce*” to another hardcore progressive scheme to benefit the NWO.

Other observations: Many believe that ObamaCare is a new way for the government to spy on us: the IRS will be the NSA's agents for domestic spying, and there will be a massive collection of private data – the largest consolidation of data in history – into the “Federal Data Services Hub,” which many agencies and subcontractors (and NWO operatives) will be able to

access. The website has already caused great concern for privacy and personal security. Hackers and identity thieves ought to have a heyday.

So ought the frauds and scammers. ObamaCare is already becoming the new playground for ripoff artists. The question is, how many millions of unsuspecting Americans will cough up their social security numbers and bank account information to those masquerading as ObamaCare representatives? We will likely never know the real numbers, but based on the history of fraud in Social Security, Medicare & Medicaid, Food Stamps and other entitlements, the numbers will be staggering.

We are beginning to see that “death panels” and the rationing of healthcare are not myths.

We are already beginning to see the true intent of the redistribution of wealth scheme: If we do not sign up for ObamaCare, in 2014 adults will pay a penalty of 1% of annual income or \$95 per adult, whichever is greater, up to \$285 per family; and by 2016 adults will pay a penalty of 2.5% of annual income or \$695 per adult, whichever is greater, up to \$2,085 per family.

MY FELLOW AMERICANS: This is not taxation; this is extortion. It does not matter that the penalties are cheap as compared to the insurance. Our government does not have the authority to force us to buy something, nor can it fine us when we don't. This isn't Nazi Germany; this is America and we are Americans! “*Period.*”

There are other penalties too. For instance, hidden until now but emerging is the fact that the young and fit will carry the burden for the elderly and ill; and unless a substantial portion of the 19 million uninsured young Americans – aged 18 to 34 – sign up, rates for all will go up dramatically. For another example, in 2014 small businesses with group health insurance will be subjected to a “community rating,” which will make insurance much more expensive for firms with healthy employees. Smokers, too, will be hit and hit hard; but the morbidly obese will not be affected. It seems that fairness is no longer in the liberal vocabulary.

We foresee a dramatic increase to the already obscene levels of favoritism, nepotism and cronyism, as evidenced by the no-bid contracts given to website designers – even to a Canadian company; as evidenced by the fact that a private website developer could have built the ObamaCare site for about \$5 million, but will cost us nearly \$1 billion with the Obama administration's friends; as evidenced by the unlawful mandate extensions granted to big businesses, but not to individuals; and as evidenced by the 1200 illegal waivers granted to staff and friends and their families. In fact, President Obama and his family and his staff and their families were allegedly the first to receive waivers in early 2010, while the bill was still being drafted.

And, we are noticing that health insurance companies are strangely quiet despite the government takeover of their free-market industry.

NOTE TO INSURERS AND BROKERS: Where is the outrage? Your businesses are under attack. Your profits and livelihood are being stolen, under “color of law,” by the NWO. Are you in on it?

NOTE TO THOSE LOSING THEIR HEALTH PLANS: Keep track of your damages. My next two books will propose remedies.

ObamaCare will cost our nation trillions of dollars. It is *unaffordable*. It is *unsustainable*. It will ruin our economy. It will bankrupt our Country. A couple of billion dollars for websites and a couple of trillion dollars to implement it are just drops in the bucket. As the scheme falls short each year, trillions of dollars more will be added to the public debt to operate ObamaCare and the \$90 trillion or so in unfunded liabilities for Social Security, Medicare and now ObamaCare, will grow like a weed.

Millions of Americans will soon see that ObamaCare is nothing more than a power-grab by our domestic enemies, *for the NWO*, to control 16% of our economy and to institute another

massive unaccountable unneeded bureaucracy that will help our foreign and domestic enemies launder even more thefts from our Treasury each year.

ObamaCare represents the takeover of one-sixth of our economy; it is a coercive effort to socialize our Country; it is the legalization of theft; it is governmental control and abuse in the highest order.

ObamaCare is the *epitome* of treason in the new millennium.

CASE FIXING:

Flying under the public's radar for decades, though, has been our judicial branch, where the true magnitude of the treason is unimaginable.

MY FELLOW AMERICANS: I am an expert in – and a victim of and a whistleblower of – the “case fixing” taking place all across the United States in the fields of family law and the criminal justice system, and have summarized it in this section.

As shown in the previous section, appellate cases are fixed to set “*precedence*” for the NWO and to legally bind all Americans to the customs and practices of a few. In the 1970s, we were forced to accept “*reproductive rights*,” and today we are being forced to accept “*no-fault divorce*,” gay marriage and socialized medicine in our Country.

Individual court cases are fixed to increase profits and federal funding, and/or to accomplish a certain goal of the traitors, such as to destroy the family unit in America, to take private property for the state, or to erode our freedoms.

Cases are fixed in a variety of ways by judges, attorneys, prosecutors, public defenders, law enforcement officials, child support enforcement officials, guardian ad litem, and other officers of the court, and by court reporters, court administrators, probation and parole agents, treatment specialists, and other court cronies, who are willing to commit crimes such as fraud upon the court, mail fraud, perjury, subornation of perjury, extortion, conspiracy against rights, deprivation of due process and other rights, acting outside authority, issuing false orders and fictitious obligations, etc., or who are willing to obstruct justice or influence the proper administration of law by refusing to investigate, refusing to apprehend, refusing to charge, or otherwise neglecting official duties, executing false arrest warrants and serving other unlawful orders, processing fictitious obligations, manufacturing evidence, falsifying documents, altering records or accounts, framing defendants, tampering with witnesses, denying access to the court system, etc.

Case fixing is never done out of ignorance or inadvertence - it is a willful, conspired, calculated, treasonous crime.

Today, nearly all family law cases and criminal cases are fixed in some way to maximize profits and federal funding, and to play a role in the overall plot to destroy the American family.

The scandal is enormous. Justice is being bought and sold in many of our 180,000 local communities. And many states are also profiting from the treasonous crimes.

As one result, almost half of America's children are currently being raised without a father.

CASE FIXING IN FAMILY LAW:

- Tens-of-thousands of family law ‘*professionals*’ churn and fix court cases and administrative proceedings, especially in divorce, for extra profits and federal funding.
- Once the corrupt officers of the courts have the families’ financial information, they pit the parents against each other in unnecessary and unlawful *custody battles* until they are broke, unconstitutionally subclass one of the parents as *noncustodial* and *deviate from the presumptions of equality* to jack up the child support orders, dole out restraining orders like candy, fill up the jails with distraught parents, and engage in many other illegal “*case fixing tactics*,” all designed to pad their numbers for state and federal funding, from which, many of the racketeers have found ways to line their own pockets.

- And once the family is broken and separated, many of the unfairly classed noncustodial parents, normally the ‘*breadwinners*’ and therefore normally the fathers, are forced to fight non-stop to see their children and to maintain contact with them, are blocked from modifying their child support and denied access to the courts, and are treated like criminals and obstructed by law enforcement in their pursuit of justice and protection for their families.
- There is a huge incentive for the courts and officers of the court, human service offices and child support enforcement and child protection officials, police departments and sheriff offices, and many other local and state offices and officials, to criminalize noncustodial parents and cook their books to cheat the system to obtain more state and federal funding than they deserve.
- Many involved in the family law process pad their numbers for extra state and federal funding, from which many of the officials have found ways to line their own pockets.
- Family law judges are ignoring legitimate family laws, common law precedence and the Ninth and Fourteenth Amendments to the Constitution of the United States, which protect our rights to equal parenting; and are blatantly deviating from controlling law, constitutional guarantees, and presumptions of equality and parental fitness, to purposely reduce the role of the noncustodial parent in the raising of his or her children because it will jack up the child support order and result in increased funding for the local courts and government offices.
- Family law judges are also ignoring basic *parental rights* and *familial rights*, which, although not explicitly mentioned in the Constitution, were well-established by centuries of English common law and by our Founding Fathers, formed the very foundation of the Constitution itself, have been regarded as fundamental to the pursuit of happiness in the United States, and have been upheld in just courts throughout our history.
- All states also have laws and precedence to protect parental rights, children’s rights, and the institution of the family, which are often ignored by judicial officials, who use instead illegitimate family laws produced by corrupt legislators to maximize profits and funding, to break apart families for the NWO, and to harass and oppress the noncustodial parents and other victims of their treasonous crimes.
- Many local, state and federal officials, including high-ranking officials, know all about the case fixing in family law, but look the other way so their state and their offices will receive larger and larger appropriations from Congress each year.
- Millions of divorced and divorcing American parents have been unconstitutionally sub-classed as noncustodial parents over the past several decades and intentionally harmed and oppressed to aid the NWO in their mission to destroy the American family (and are therefore entitled to compensation for their injuries).
- Millions of American children have been forced to grow up without one or both of their parents, as part of the scheme (and are therefore entitled to compensation for their injuries).
- And although many of the *custodial parents* capitalized on their new-found status and essentially partnered with our domestic enemies to take advantage of and oppress their ex-spouses, some are themselves victims of the case fixing in family law (and are entitled to compensation for their injuries along with their ex-spouse and their children).

CASE FIXING IN THE CRIMINAL JUSTICE SYSTEM:

- Tens-of-thousands of criminal justice system ‘*professionals*’, including judges, prosecutors, public defenders, law enforcement officials, parole and probation agents, ‘treatment’ specialists, and other court cronies, are framing criminal defendants and fixing court cases for extra profits and federal funding.
- Many criminal defendants are known to be innocent of the charges, but are prosecuted anyway.
- Nearly all criminal defendants are ignorant in the law.
- Nearly all criminal defendants are first framed at their bail hearing as a ‘*flight risk*’ to jack up the *cash bail* orders; whatever cash bail is posted usually becomes the price of the *plea deal*; and

many times only a small fraction of the paid cash bails and plea deal fines are recorded and the rest is divvied up between the racketeers.

- Most plea deals offered to poor defendants are conspired upon by their public defenders and the prosecutors to benefit the state; whoever cannot pay the cash bail or the plea deal fines will likely spend an excessive amount of time in jail or prison, so that the county, state and federal offices involved can at least maximize their federal funding.
- There are huge incentives for the courts and officers of the court, including the judges, the prosecutors, the public defenders, the parole and probation agents, counselors and treatment specialists, local law enforcement, and many other local and state offices and officials, to conspire and work together to make false arrests, to issue unwarranted restraining orders, to frame innocent citizens and other criminal defendants for excessive bail and fines and sentences, to intimidate suspects into accepting unfair plea deals, and to fill up and maintain full capacity at the local jails; and, when their victims complain, the racketeers turn them away, deny them crime victim services, mislead them, obstruct justice, deny access to the courts, treat them like they are the criminals, and do whatever it takes to keep the truth off the record.
- Many involved in the criminal justice system pad their numbers for extra state and federal funding, from which many of the racketeers have found ways to line their own pockets.
- Thousands of innocent criminal defendants are incarcerated each year.
- Millions of criminal defendants are subjected to excessive bail, excessive fines, excessive jail and prison terms, and excessive parole and probation terms each year to maximize funding.
- Billions of dollars are extorted each year from the innocent, the poor, the young, the old, the ignorant, the *pro se*, child support debtors, and other criminal defendants.
- The *rights of the accused*, including the right to counsel, the right to bail, the right to witnesses, and the right to a fair trial, are violated millions of times each year.
- *Crime victims' rights* are denied millions of times each year.
- And many local, state and federal officials, including high-ranking officials, know all about the case fixing in the criminal justice system, but look the other way so their offices will receive larger and larger appropriations from Congress each year.

Justice is bought and sold like this, every day, nationwide. And it is very obvious, even to people who are not in the legal profession. But, because many local law enforcement officials are on the dole for a portion of the extortions, crime victims are routinely treated like dirt and, if they won't go away, are criminalized and framed on false charges.

And when victims sue, the case fixers scream "*absolute immunity*" and "*qualified immunity*," and, because they know that the facts are irrefutable and the evidence cannot be rebutted, they will do practically anything to block their victims' access to the courts and prevent the truth from being entered on the public record in their jurisdictions.

Thousands of state and federal judges and other judicial officials are fixing court cases and they know that thousands of victims like me have a mountain of evidence to prove their treasonous crimes. So, over the years, with the help of corrupt legislators, the traitors have taken near total control of the grand jury process and have rigged legislation and precedence to grant themselves immunity and avoid the charges they deserve.

This will all change under The People's Branch.

CASE FIXING TACTICS:

The following is an abbreviated list of case fixing tactics being used against parents, *pro se* litigants, indigents, criminal defendants, the young, the old, the ignorant, crime victims, and victims of government abuse:

Judges:

- "Impute" income in divorces to jack up child support orders.

- Lower a fit parent's parenting time to jack up child support orders.
- Dole out restraining orders like candy.
- Allow perjury and other fraud upon the court.
- Promote fraud upon the court.
- Commit fraud upon the court in their orders.
- Suppress evidence.
- Ignore allegations and evidence of criminal misconduct and prosecutorial misconduct.
- Ignore precedence that is in favor of their victims.
- Use precedence that favors the state or the traitors.
- Deviate from the presumptions of equal custody, equal decision making, equal parenting time, etc., without a showing of parental unfitness.
- Refuse to enforce visitation orders, but enforce custody orders and child support orders for custodial felons.
- Deviate from the presumption of truth in affidavits without cause or reason.
- Deny applications by indigents for fee waiver status, deny applications by victims for crime victim services, and refuse court services to criminal defendants.
- Deny due process and equal protection under the law to noncustodial parents and criminal defendants;
- Criminalize child support 'debtors.'
- Order excessive bail and require 'cash-only' payments.
- Order excessive fines and require 'cash-only' payments.
- Hold criminal defendants without bail to maximize jail time for federal funding.
- Issue false arrest warrants.
- Deny access to the court system.
- Label *pro se* litigants, and victims that fight back, "frivolous" and "vexatious."
- Order criminal defendants to pay their bail in cash, post say 10% on the books and divvy up 90% with the other racketeers.
- Order the payment of all fines and treatment in cash, post say 10% on the books and divvy up 90% with the other racketeers.

Attorneys:

- Learn of the parents' finances from their "Financial Affidavits," conspire with opposing counsel, and churn the case until both parents are broke.
- Lie about material facts.
- Pit moms against dads in "custody battles" knowing they are fit parents and entitled to equal time.
- Encourage domestic violence scams.
- Encourage "Parental Alienation" and other child abuses to turn the kids against their other parent.
- Break up the family in any way imaginable.
- Sacrifice as many childhoods and parenthoods as possible to become rich.
- *Prosecutors:*
- Label all defendants a "flight-risk" to jack up the bail orders and maximize extortions.
- Conspire to put say 10% of the cash bails posted on the books and divvy up 90% with the other racketeers.
- Refuse to dismiss cases that 'ought not to be prosecuted.'
- Refuse to answer counterclaims.
- Refuse to answer discovery requests.
- Knowingly advance cases without establishing probable cause;
- Invent probable cause.

- Knowingly advance cases without jurisdiction;
- Assume jurisdiction.
- Knowingly advance fallacious arguments;
- Openly commit fraud upon the court.
- Withhold exculpatory evidence.
- Knowingly violate their oaths of office, both as an attorney and as a prosecutor.
- Participate in the renumbering and altering of exhibits in the event of an appeal.
- To maximize the extortions, threaten and intimidate defendants and their relatives to take unfair plea-deals in favor of the state, which many times are designed to be the maximum fines, jail time, and ‘treatment’ assessable by law for the charge if they had been found guilty by a jury.

Public Defenders:

- Refuse to do anything to defend.
- Refuse to do anything in writing.
- Refuse to move for dismissal, challenge probable cause, challenge jurisdiction, etc.
- Refuse to obtain transcripts.
- Refuse to do discovery.
- Refuse to subpoena any witnesses.
- Refuse to file court documents, or just present them in court so the clerks can throw them away.
- Make only verbal statements in court and only statements that will benefit the racketeers.
- Intentionally fail to object, to undermine any appeals.
- Participate in the altering of exhibits, to undermine any appeals.
- Scare ‘clients’ and clients’ relatives with large fines and long prison sentences if they don’t take the prosecutor’s unfair plea-deals designed to be the maximum fines, jail time, and ‘treatment’ assessable by law for the charge if the defendant were found guilty by a jury.
- Answer clients’ questions with “We’ll talk about it in court,” and then, to maximize the PD’s share of the extortions, scare the client on his day in court so that he will relinquish his bail money for the plea-deal conspired with the prosecutor.

Law Enforcement:

- Tell crime victims that they should get an attorney to correctly report the crimes.
- Refuse to look at evidence.
- Refuse to do investigations.
- Refuse equal protection.
- Refuse crime victim services.
- Help paint the ‘breadwinner’ in divorces as a bad parent.
- Manufacture evidence against criminal defendants.
- Payoff snitches or pad their commissary accounts to rat out their friends and relatives.
- Shakedown criminal defendants while in jail.
- Threaten and intimidate the accused and their relatives to help facilitate the unfair plea-deals for the other corrupt officers of the court, to maximize fines, jail time, treatment, other lucrative money making schemes of the racketeers, and law enforcement’s share of the extortions.
- Accept only cash for fines and bail, post say 10% on the books and divvy up 90% with the other racketeers.

Court Administration; State and Federal Clerks:

- Deny access to the judicial system.
- Refuse to file court documents.
- Refuse to provide court forms.
- Refuse to seal subpoenas.

- Refuse to serve complaints for indigents.
- Throw away or misplace indigents' IFP applications and other court documents.
- Alter the Docket or 'Register of Actions' when decisions are appealed.
- List the motions and other pleadings of *pro se* litigants as "Other Document" to help fix appeals.
- Rename or renumber exhibits, or lump several exhibits under one number, so some or all can be withheld in the event of appeal.
- Accept only cash for fees and fines, post say 10% on the books and divvy up 90% with the other racketeers.

Court Reporters:

- Refuse to produce transcripts.
- Alter transcripts when decisions are appealed.
- Provide timely transcripts to custodial parents, prosecutors, and plaintiffs, but delay transcripts for months or deny them altogether for noncustodial parents, defendants, indigents, *pro se* litigants, etc.

Probation/Parole Officers:

- "Violate" clients for noncompliance knowing they are innocent.
- Invent charges.
- Manufacture evidence.
- Deny due process.
- Cause "offenders" to be re-incarcerated on known false charges.

Child Support Enforcement (CSE) caseworkers:

- Refuse to verify facts and perform reviews, adjustments, modifications, and other due processes related to child support.
- Invent false facts.
- Refuse to disclose custodial parent's application and cover up fraud.
- Refuse to credit payments.
- Alter Title IV-D accounts, arrears balances, etc.
- Refuse to correct interstate accounts under the guise of the 'full faith and credit' laws.
- Steal and extort from the noncustodial parents.
- Lien and levy bank accounts without due process, even kids' trust accounts if held under S.S.# of noncustodial parent.
- Send Lien & Levy Notices to the bank, but hold the noncustodial parents' notices so they will miss the appeal periods.
- Levy bank accounts repeatedly just to increase federal funding.
- Ruin the noncustodial parent's credit without due process.
- Suspend driver's licenses without due process.
- Refuse to use appropriate discretion to reinstate driver's licenses when warranted.
- Report known false arrears balances to credit reporting agencies without due process.
- Commit and suborn perjury.
- Increase support collection without notice or hearing; then garnish from the noncustodial parent's paycheck.
- Allow custodial parents to use child support money for expenses not related to child care.
- Deny modification unless unemployed noncustodial parent can prove they are mentally or physically incapacitated.
- Accept only cash from some noncustodial parents and then pocket the cash and fail to record it.

Child Protective Services (CPS) caseworkers:

- Deny due process and equal protection if contacted by the noncustodial parent.
- Ignore the child abuse laws when contacted by the noncustodial parent.
- Refuse to investigate child abuse reports by noncustodial parents.
- Refuse to interview the witnesses of noncustodial parents.
- Ask the kids leading questions during investigations and misquote them in reports if they say anything nice about the noncustodial parent.
- Manufacture evidence.
- Commit and suborn perjury.
- Defraud law enforcement and the courts for the custodial parent.

Others 'Cronies' Involved:

- Guardian Ad Litem (GALs); "Child and Family Investigators" (CFIs); Custody Evaluators; Psychologists; Women's Shelters; Mediators; 'Alternative Dispute Resolution' personnel; 'Counselors' and 'Treatment' Specialists.

OTHER TREASONOUS CRIMES:

Officials in all three branches of our government are committing treasonous crimes. If you've seen it in a movie, they're doing it. If you can imagine it, they're likely doing it. If you've suspected it in your office, they're likely doing it.

Treasonous crimes are being committed rampantly from coast-to-coast in our Country, in all three branches, and at every level of our government. Criminal factions in most if not all federal offices, and in a growing number of state and local offices – some infiltrated by the NWO and others driven by their own greed – are directly aiding in the treason or running their own rackets, and have found all sorts of ways to ripoff the American taxpayers and to profit from unsuspecting citizens who are sucked into their madness.

There are hundreds of ways to participate in the treason. A partial list of treasonous crimes includes:

- Case fixing, racketeering, destruction of family, fraud, theft, malicious prosecution, framing, false imprisonment, and other judicial abuses;
- False arrest, induced confessions, obstruction of justice and other law enforcement abuses;
- Legislation and election rigging, tyranny, oppression, torture, enslavement, and other governmental abuses;
- The murder of a family member, induced suicide, induced abortion, and other population reduction tactics; and
- The subprime mortgage scandal and resulting foreclosure crisis.

Several of these treasonous crimes were examined in previous sections. This section will focus on a few more.

Many of our local, state and federal leaders know all about the treason and treasonous crimes, but simply look the other way because they want the extra funding it will bring for their offices. This is not only criminal negligence but also, in my opinion, a betrayal of our trust rising to the level of aiding our enemies in an overt act of treason. Inaction is an omission of duty, but it is also, in this instance, a conscious act to aid in the treason or in a treasonous crime by looking the other way.

Many of our local, state and federal leaders know all about the treason and treasonous crimes, but look the other way because they are involved in one or more overt acts of treason or in the treasonous crimes.

Many Attorney Generals, for example, know about the case fixing, and some are involved to

the extent that they instruct their offices to intentionally neglect their duties to intervene, to shun victims of government abuse, and even, as I have witnessed, to participate in the framing of victims and whistleblowers. Recent writings and documentaries suggest that some attorney generals, lawmakers and other high officials have rigged legislation and have entered into agreements with the NWO's banks to fast-track foreclosures so the traitors won't have to wait so long to reap the benefits of their subprime mortgage bubble. If true, this should certainly be regarded as a treasonous crime, and, if the officials are found to have known that they were aiding in the overall treason itself, they should be prosecuted and punished right along with the rest of the traitors.

Other reports show that many County Commissioners and City Managers have either been hoodwinked into collateralizing public lands in their jurisdictions and investing in derivatives and other risky gimmicks designed to benefit the NWO, or have sold out altogether and are willfully doing these things and more, such as setting up secret reserve accounts, incrementally raising property taxes, and diverting surpluses to the traitors and/or to themselves.

In addition, in each of the overt acts of treason listed previously in this chapter, one or more treasonous crimes were committed to aid in the overall mission to incrementally take control of our government and resources. For instance, the first terrorist attack on the World Trade Center in 1993 was an overt act of treason, as part of the NWO's overall plot to overthrow our Country, and the payoff to the terrorists by the FBI was a treasonous crime, as part of our domestic enemies' aid to our foreign enemies.

LIKE OUR FEDERAL GOVERNMENT, many state, county and city governments appear to be under the control of a few as well. For instance, in my state, the Governor, the leaders of the House and Senate, and the Chief Justice, i.e., the highest authorities of state government, know all about the case fixing and other treasonous crimes, as do my county commissioners and mayor, i.e. the highest authorities of local government; but all just ignore it, as though it doesn't exist and will never be exposed. The governor's knowledge of the overthrow of our state government – or the attempt thereof, if still underway – and his inaction in dealing with it, prove his complicity in the treason. And the same goes for the other high-authorities.

Presidents and Governors and other high-ranking officials can commit no greater crime than to knowingly look the other way. Lawmakers can commit no greater betrayal of our trust than to pass known unconstitutional legislation. Judges can commit no greater treasonous crime than to fix a case. Prosecutors can commit no greater crime than to frame an innocent citizen. Law enforcement officials can commit no greater offense than to turn away a crime victim. And when officials in our government commit these high-crimes they are warring against the United States or aiding our enemies.

As the legislation and election riggers, case fixers, racketeers, justice obstructors, duty neglecters, and our other domestic enemies are brought to justice, the scope of their treason and treasonous crimes against the United States, against their state, against the people of their state and against their victims, will become fully known and documented.

The treasonous crimes will end as soon as the traitors know that millions of Americans are behind The People's Branch.

All Americans who are "direct victims" of treasonous crimes should be entitled to exemplary damages and will have an opportunity in the near future to fill out an "Affidavit of Damages" on

the official websites. If you have further information or evidence to prove any act of treason, any treasonous crime, or any criminal misconduct by public servants, you will be able to submit it soon.

MY FELLOW AMERICANS: The foregoing facts in this chapter will likely be held out to the American People as controversial and conspiratorial by our foreign and domestic enemies, but keep in mind that verifiable evidence exists to prove every fact and all facts will be proven in our courts during our civil and criminal actions against them.
